

**HILLSIDE FIRE CONTRACT  
2020**

This agreement, made on the \_\_\_ day of \_\_\_\_\_ 20\_\_ between the Town of Rhinebeck, a municipal subdivision within the County of Dutchess and State of New York, party of the first part, and Hillside Fire District, a municipal subdivision. Located within the Town of Rhinebeck, County of Dutchess, and State of New York, party of the second part,

**WITNESSETH**

The parties hereto, in consideration of the covenants and agreement herein contained, hereby DO AGREE, as follows:

1. That the Town of Rhinebeck does hereby agree to pay to the Hillside Fire District the sum of \$28,000 for the period of January 1, 2020 through December 31, 2020.
2. In consideration of such payments. The Hillside Fire District will be a member of the Dutchess County Aid Plan and shall provide fire protection in an area of the Town of Rhinebeck known as the Rhinebeck Fire Protection District. More particularly, the Hillside Fire District shall be given first call and shall be responsible to answer demands for fire protection in the following portions of the Township of Rhinebeck contained within the Rhinebeck Fire Protection District on Primrose Hill Road, Schultz Hill Road, Vlei Road, Ackert Hook Road, Wurtemberg Road (south from Frost Road to Town of Hyde Park line) and generally, property adjacent to Route 9 from the village of Rhinebeck south to Fox Hollow Road.
3. The Hillside Fire District agrees to furnish and provide general liability insurance on its own equipment while going to and from emergency dispatches or while engaged in emergency dispatches in the Town of Rhinebeck, and agrees to provide general liability insurance against any act of its firemen while going to or from an emergency dispatch or while engaged in an emergency dispatch in the Town of Rhinebeck.
4. The Hillside Fire District agrees to provide Workman's Compensation, liability insurance and all other insurance necessary to protect the firemen against injury and to protect the Town of Rhinebeck against injury and to protect the Town of Rhinebeck against any or all liability for the safety of the firemen and for the protection of the Town Of Rhinebeck against all liability for all loss arising hereunder and to save the Town harmless from responsibility. The Town of Rhinebeck shall in no way be liable for any damages arising to the equipment of the fire companies or to the Hillside Fire District; which may be suffered by the same in going to or from a fire or while engaged in fighting a fire.

5. This agreement shall extend over a period of one year commencing January 1, 2020 and ending December 31, 2020 midnight.

IN WITNESS WHEREOF, this agreement has been signed on the day and year first written, by the Town of Rhinebeck supervisor and by the Fire Commissioners duly elected in the said Hillside Fire District.
