PUBLIC HEARING NOTICE

PLEASE TAKE NOTICE that in response to the Covid-19 pandemic and in accordance with the Governor's Executive's Order 202.1, the Town of Rhinebeck Zoning Board of Appeals (ZBA) will not be meeting in person at Town Hall, and instead will be conducting its meeting and public hearing virtually via Zoom.

PLEASE TAKE FURTHER NOTICE that the Zoning Board of Appeals of the Town of Rhinebeck will hold a Public Hearing via Zoom, pursuant to Section 267 of the Town Law and in accordance with Executive Order 202.1, on the Application of:

The Zoning Administrator reviewed the Building permit application for a Single Family Residence and garage. The parcel is 0.38 acres and lies within the RA 10 Zoning District.

The findings are that the site plan layout does not meet the Town Zoning code requirement in the area as follows: Four (4) Area Variances are required:

1. Front yard setback
Required = 150 feet
Proposed = 56' 5" feet
Variance Requested = 93' 7" feet
2. Side yard setback (from north side)
Required = 100 feet
Proposed = 25' 2.5" feet
Variance Requested = 74' 9.5" feet
3. Side yard setback (from south side)
Required = 100 feet
Proposed = 23' 3" feet
Variance Requested = 71' 3" feet
4. Allowable buildable coverage = 7% of Lot area
Required = 1,163 SF
Proposed = 1,770.75 SF
Variance Requested = 607.75 SF

Said Hearing will be held via Zoom, Wednesday, May 19, 2021 at 7:05 p.m. A link to the Zoom meeting will be provided on the Town of Rhinebeck's Zoning Board of Appeals' webpage at approximately 6:00 PM the night of the meeting. The meeting may also be viewed on the Town's Website (homepage), which will live-stream the zoom meeting.
